Risk Examination

Task: Manual handling

Significant Hazards: Injuries to back, arms, shoulders and neck
Cuts and abrasions
Fractures

Persons At Risk: Band members – Lee Hines, Harley Elkins, Alan Taylor, Gary Blundell

Risk Level: Medium

Control Measures: Equipment stored in correct suitable cases
Equipment will be lifted by the correct handle
Larger Equipment to be moved by two people
Adopt a good posture – bend from knees, Ensure good grip / keep shoulders level / face shoulders in same direction as hips / keep arms in boundaries of shoulder where possible
The load will be kept as close to the lifter as possible.

Residual Risk: Low
